Secretary's report - Karen Fenstermaker

# Treasurer's report - Debby Tanico

Debby presented the budget for 2026 and highlighted expected income for our event fundraisers, the Manor Shoppe, Treasure Trove, and Crafters. She noted that the budget is balanced and the society is in good financial standing. Carol Holt called for a motion to accept the budget and it was seconded. A voice vote was taken and the budget acceptance was passed.

Debby, then referred to the 2025 budget, highlighting income from Treasure Trove, Blooms, Bingo, and gift cards. A motion was made by the finance committee to give an additional \$90,000 to the Benevolent Fund. Carol Holt called for a vote and the motion was passed. It was noted that the Society has donated a total of \$175,000 to the Benevolent fund this year.
